1. Competitive sealed Tenders are invited for the sale of scrap sale of scrap/obsolete /unserviceable items **IN ONE LOT** lying at this office on **"AS IS WHERE IS BASIS"** without any guarantee in its quality, measurement, number and weight. The reserve Price is fixed at Rs. 1,000,00 (Rupees One Lakh only)
2. The tender must be submitted in sealed cover accompanied with the EMD of Rs. 10,000 (Rupees Ten Thousand) in the form of Demand Draft/Pay Order drawn in favour of **"Pay and Accounts Officer" Ministry of Corporate Affairs, payable at Mumbai.**
3. The Tenders not sealed or without the EMD or received after the due date and time, will be summarily rejected. While sending the sealed tender, it must be indicated on the envelop **"TENDER FOR THE DISPOSAL OF SCRAP/UNSERVICEBLE ITEMS"**.
4. The items can be inspected on any working days between 11 AM to 5 PM from 4/4/2016 to 7/4/2016. The inventory of items may be taken from the office after paying Photostat charges.
5. The last date for submitting Tender is 11.04.2016 up to 3 PM. The Tenders will be opened on 11/04/2016 at 4 PM before the Committee. The Tenderer or their authorized representative may participate while opening the tender and *inter se bidding will also be held in their presence*
6. The successful Tenderer will have to make full payment by way of Demand Draft/Pay Order drawn in favour of **"Pay and Accounts Officer" Ministry of Corporate Affairs, payable at Mumbai within a day failing which the EMD will be forfeited.**
7. The EMD will be forfeited if the successful tenderer rescind from his offer for whatsoever reasons.
